Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Additional Central Provident Fund Commissioner, Thiruvanthapuram has requested to the Government to cancel the exemption granted to M/s Fertilisers and Chemicals Travancore Ltd, Udyogamandal Division under Para 27A of the Employees' Provident Fund Scheme, 1952. The Central Board of Trustees has also recommended for the cancellation of exemption granted to the said establishment under the said provisions of the said scheme. The Government have examined the matter in detail and have decided to cancel the exemption granted to Udyogamandal Division bearing code No.KR/KCH/165 under Para 27A of the Employees Provident Fund Scheme, 1952.

The notification is intended to achieve the above object.
