Whereas, the Governor was pleased to exempt the establishment namely, M/s. Progressive Publicity Service Ltd, 16/3, Gariahat Road, Kolkata-700019 against the PF code No. WB/PRB/5037 vide notification No.2148/1(I)P.F. dated 08.04.1970 under section 17(1)(a) of the Employees' provident Fund & Miscellaneous Provisions Act, 1952 from the operation of all provisions of the said Act of Employees' Provident Fund Scheme, 1952, subject to the conditions specified Whereas, it has been reported by the Addl. Central P.F. Commissioner (Exemption) vide No. EXEM/10(105)/2017/WB/5037 Dated- 19/01/2023 that

- The board of Trustees in on 10.01.2019 unanimously passed a resolution to surrender exemption w.e.f. 01.04.2018. expensing their inability to run the trust fund with small number of employees.
- ii. The application of the establishment for surrender of Exemption was placed before the Exempted Establishment Committee of the Central Board, in their 51st meeting held on 18.10.2022 and subsequently to the 232nd meeting of the Central Board of Trustees, held on 31.10.2022 & 01.11.2022.
- lii. The establishment has furnished the third party Audit Report for the financial year 2017-18 & 2018-19 (upto 31.03.19).
- iV. And whereas the Jurisdictional Regional Provident fund Commissioner, Kolkata has also reported that the establishment has started reporting compliance to EPFO with effect from 01.04.2019 and all the securities along with past accumulation of the members lying in the P F Trust has also been transferred in the name of Central board of Trustees, EPF.
- V. The Central Board of Trustees has recommended the acceptance of Surrender application of M/s. Progressive Publicity Service Ltd., WB/PRB/5037 for a formal cancellation of exemption under section 17(4) of EPF & MP Act, 1952.

And whereas Central board EPFO has requested to consider for issuance of necessary formal order regarding cancellation of exemption in respect of the said establishment.

After considering the proposal of EPFO authority and the correspondences, documents it may be deduced that M/s. Progressive Publicity Service Ltd 16/3, Gariahat Road, Kolkata-700019 has Surrendered its exemption and act as unexempted establishment, the recommendation of cancellation from the EPFO authority seems to start solid and valid.

Now, the Governor is hereby pleased to cancel the exemption of the M/s. Progressive Publicity Service 16/3, Gariahat Road, Kolkata-700019 against the EPF code WB/PRB/5037 vide Notification No- 2148/1(I)P.F. dated 08.04.1970 as per section 17(4) of the Employees Provident fund Miscellaneous Provisions Act, 1952 and as per section 27 of the Employees Provident fund Scheme 1952, from the date of issuance of the notification.
