NOTIFICATION

M/S Haplitus Technologies Pvt. Ltd bearing Code No. BG/BNG/42680 an establishment covered under Employees' Provident Fund & Miscellaneous Provisions Act, 1952 was granted exemption under Para 27A of EPF Scheme, 1952 vide Government Notification No. LD 101 LWA 2008 dated: 24.08.2009 w.e.f. 01.11.2007 in the name of M/S Data Card Software India Pvt. Ltd.

The Competent Authority, the Regional Provident Fund Commissioner of the erstwhile, Regional Office, Bengaluru reported that the aforesaid establishment ceased its commercial operations due to poor business conditions and consequently decided to wind up its Provident Fund Trust w.e.f. 01.10.2012. The Regional Provident Fund Commissioner affirmed that the past accumulations of all the members were settled as per the Balance Sheet. Further, The Regional Provident Fund Commissioner recommended the cancellation of exemption to the Central Board of Trustees, Employees' Provident Fund Organization, as per the existing guidelines. The establishment had also expressed their willingness to surrender the Trust consequent upon winding up of its operations.

The Central Board of Trustees, EPF 231st held on 29.07.2022 and 30.07.2022 considered the recommendations of the Regional Provident Fund Commissioner based on the application submitted by M/S. Haplitus Technologies Pvt. Ltd., bearing Code No. BG/BNG/42680 for cancellation of exemption under section 17 (4) of Employees' Provident Fund & Miscellaneous Provisions Act, 1952.

Now, therefore, in exercise of the powers conferred under section 17 (4) of EPF & MP Act, 1952 the Govt. of Karnataka hereby cancel the exemption granted under Para 27 A of EPF Scheme, 1952 to M/S Haplitus Technologies Pvt. Ltd bearing Code No. BG/BNG/42680 issued vide Notification No. LD 101 LWA 2008 dated 24.08.2009 w.e.f. 01.10.2012.
